A cleaning fee of \$100.00 shall be assessed after the event, if cleaning or clearing of your assigned area is required. Sponsors shall not dispose of any waste products within or near the festival ground(s).

Sponsorship Restrictions/ Requirements

- 1. Sponsors with KCFB-provided tent space shall have the primary use by the named businesses on the Sponsorship form and/or directly affiliated with that business and included in the sponsorship documents.
- 2. Use of KCFB-provided tents by the sponsor in an unsafe, objectionable, unhealthy or violates any legal rules or regulation shall not be permitted and subject to removal and/or termination of the sponsorship with the loss of paid fee(s).
- 3. Distribution and/or sales of novelty items shall not be allowed without the prior approval of KCFB and shall be specified as part of the sponsorship documents under "Giveaway".
- 4. Sponsor may not alter and/or expand outside the assigned and designated tent space.
- 5. Before, during the event and following the event closure/clean up, the Sponsor shall comply with and follow any and all KCFB policies/ procedures/ guidelines regarding health concerns, security issues, and other emergency situations. This includes any and all verbal instructions given by KCFB's authorized representative(s) in compliance with the fore mentioned rules, regulations, policies and guidelines. Compliance is necessary to ensure and to secure the health and safety of Sponsor, the public and festival volunteers.
- 6. Sponsors shall secure and safeguard their products, equipment/tools, signage, tables, benches, accessories and assigned area for the duration of the Festival. KCFB shall not be responsible for any Sponsor's losses due to fire, accident, theft, loss or injury, property damages, etc. while participating at the Festival.
- 7. In compliance with the County of Kauai's Zero Waste Policy, all serving ware(s) used

shall be compostable. Styrofoam and other non-compostable food serving ware and plastic utensils are prohibited for use at the Festival.

8. Sponsor shall remove and dispose such trash/waste products from the field at the end of each day. Sponsor shall not pour any liquids, semi-liquids, solids and/or semi-solid materials other than clean or gray water without particles on to the soccer field.

Agreement between KCFB and Sponsor regarding the 2023 Agricultural Festival

This Agreement between KCFB and the Sponsor shall be governed by the laws of the State of Hawaii. Any violation of this Agreement between KCFB and the Sponsor, Sponsor shall be wholly responsible for any legal actions.

Under this Agreement, the KCFB shall not be responsible for Sponsor's financial business issues under this Agreement. Sponsor shall be solely responsible to report all their financial responsibilities from this Festival for the purposes of County, State and Federal tax liabilities.

In the event, the Agricultural Festival is canceled (example: natural damaging weather events) beyond the control of KCFB, KCFB will refund the Sponsorship fees. KCFB shall not be responsible for any Sponsor's loss(es) or damage(s) suffered due to the cancellation of the Festival.
